Richard Rouse Bloxam, D.D., Rector of Brinklow, and Vicar of Bulkington, this county, and for 38 years one of the Assistant Masters of Rugby School, Ann his wife, one of the sisters of Sir Thomas Lawrence, P.R.A. He was born at Rugby, on the 30th of April. 1799, in the house now possessed and occupied by Mrs Homer, and where his grandfather, Mr Thomas Lawrence, died in 1797. In his childhood the deceased had his profile drawn chalk by his uncle, Sir T. Lawrence. This drawing, in 1830, was engraved by Mr F. C. Lewis. In his early boyhood his portrait—a half length—was painted by Mr Harlow, the celebrated pupil Sir T. Lawrence, an artist who, but for his early death, bid fair to rival the most eminent portrait painters of this country.

The rudiments of an English education were communicated to the deceased at the Elborowe, then a mixed school this town. He entered Rugby School 1806, during the mastership of Dr. Ingles, the early age of seven. He left school when 16 years of age, being then the sixth form, and was articled to his uncle-in-law, Mr John Meredith, an eminent solicitor at Birmingham. In 1823, he settled as solicitor at Ellesmere, the county of Salop. Here remained till 1836, when he removed to Shrewsbury, and there practised during the last 36 years of his life, still retaining his practice at Ellesmere. At the latter place he was appointed by the late Mr C. Mainwaring, of Otely Park, Ellesmere, his agent and solicitor. The latter post, that of legal adviser to the late Mr Mainwaring, and his son, the present possessor of the extensive Otely estates, he retained to the close of his life. He was twice Under-sheriff for the county of Salop, the first time being appointed by the late Mr Mainwaring, the second time by his son. He presided for a short time as County Court Judge at Shrewsbury, and when, by an alteration the law, it was enacted that the County Court Judges should be barristers of a certain standing, he was appointed to the office of High Bailiff, which office he held at his decease. He was for several years Vicar's churchwarden of St. Mary's parish, Shrewsbury; he was also elected to represent the ward which he resided in the Town Council of Shrewsbury, and served as such representative for several years. A few years before his death it was privately intimated to him that if he would allow himself to be put in nomination, he would be elected Mayor without opposition. After reflection, finding, from the approach of age, and symptoms of that malady which eventually caused his death, he longer possessed the vitality and strength to perform efficiently the duties incident to that office, he felt compelled to decline. In January, 1830, he was called up to London from Ellesmere, in consequence of the sudden and unexpected death his uncle, Sir Thomas Lawrence, President of the Royal Academy of Arts. The funeral he attended on the 21st of that month, being one of the six nephews of the deceased, all of whom were present at the funeral, the eldest as chief mourner. On this occasion, the funeral being a quasi public one, at which the carriages of the Lord Mayor and Sheriffs of the City of London preceded the hearse, which was followed by 50 mourning coaches and 50 carriages of the nobility and others, and at which etiquette required a chief mourner to follow before others, a question was raised by those who conducted the funeral, whether the eldest nephew of the deceased, or the father of such nephew, being allied by marriage only to the deceased, should take precedence. On reference being made to the College of Arms, a precedent was furnished of the funeral, marshalled by Sir William Dugdale, of Sir Willoughby Dixie, who died A.D. 1670, and at which the eldest nephew attended as chief mourner, although his father was living. This decided the point, and the eldest and other nephews followed as mourners immediately after the coffin, the eldest by himself first as chief mourner; all the nephews taking on this occasion only, as being of blood to the deceased, precedence of their father. Of this funeral, the celebrated artist Turner, who was present, made a water colour drawing, in which the first group of mourners, the six nephews, are represented immediately following the coffin through the great west door of St. Paul's Cathedral. This drawing was in the Exhibition of the Royal Academy in 1830. For some years past has, with others of the Turner drawings, been exhibited at the South Kensington Museum.

Upwards of 42 years have elapsed since that funeral, and of the six nephews who attended, and all of whom were then of age, the deceased has been the first to pass away. On the 16th of January, 1857, the deceased joined with his five brothers in assisting in the performance of divine service in the church of Harlaston, Staffordshire. That day being Sunday, and the birthday of the eldest, who was rector of the parish, four of the brothers, who were clergymen, officiated in different parts of the service, whilst the two who were laymen read the lessons.

Exclusive of his professional duties, which were ever conducted in an upright and honourable manner, the leisure hours of the deceased were employed mechanical pursuits and scientific studies. Of these the chief was on the theory and practise music, and in this he excelled. As an amateur he built and reconstructed many small organs, and whenever one was set up in any church or nonconformist place of worship in his neighbourhood, his advice and opinion was often requested as to the merits or deficiency of the instrument, and this he was ever ready to give. When he was last at Rugby he devoted his attention to the plans for the proposed new organ to be placed in the School chapel, in the construction of which organ he felt much interest.

On the eve of an intended visit to Rugby in the early part of July last, he was seized with an illness which proved fatal, and the last month of his life was passed in incessant pain and suffering; this he patiently endured, receiving the spiritual consolation of the church administered by the vicar of the parish, and, with a mind unclouded, expired in full assurance of hope. His death-bed request as to his burial, that it should be most private and unostentatious, was fully carried out. His remains were followed to the grave by his son and only surviving child, his two grandsons, and three of his brothers, the spot having been previously selected by himself in the beautiful cemetery near Shrewsbury, in the laying out and planting of which he, on the formation of the Burial Board (of which he was a member) had taken the deepest interest.

THE LATE REV. R. ROWLAND BLOXAM, M.A.

Yesterday a funeral took place at Leamington New Cemetery, which was remarkable, not only for being the first at which the members the New Church Guild attended, but from the character and career of the rev. gentleman interred. The Rev. Richard Rowland Bloxam, Rector of Harlaston, was well-known in Leamington as an occasional assistant of Dr. Nicholson, of Christ Church, and as officiating other churches at various times when he made Leamington his temporary home. His genial temper, his indefatigable energy, as well his ability as a preacher, made Mr. Bloxam a general favourite. He was the eldest of the six sons the late Rev. R. R. Bloxam, assistant master of Rugby School, and at one time Vicar of Brinklow. His grandfather was a celebrated physician, residing at Alcester, and the family could trace their decent from the famed Lady Godiva. His mother was the sister of Sir Thomas Lawrence, President of the Royal Academy. In early life he was a naval chaplain, and in that capacity served on board the Blonde frigate, Captain Lord Byron, which took the remains of the King and Queen of Hawaii to the Sandwich Isles. In this expedition his youngest brother, the Rev. Andrew Bloxam, Rector of Harborough Magna, and formerly Vicar Radford, was appointed naturalist. The deceased was appointed to the Rectory of Harlaston in 1851, and in that small church the six brothers officiated at one service, the four clergymen, the Rev. Rowland, the Rev. Thomas, the Rev. Andrew, and Dr. Bloxam, taking different portions of the service, whilst the lessons were read by Mr Matthew Bloxam, the distinguished antiquary, and Mr R. Bloxam, solictor, of Shrewsbury. We may mention that one of the war robes of the chief of the King of Hawaii, together with the wooden dagger which is said to have killed Captain Cook, were brought home by the brothers, and are now in the possession of Mr Matthew Bloxam, F.S.A., of Rugby. The deceased had reached the age of 80 years, and some months ago received leave of absence from his rectory on account ill-health. He recovered sufficiently assist Dr. Nicholson, as before mentioned, but died on Tuesday last at his residence, in South Parade.

A correspondent writes as follows respecting the voyage to Otaheite: — Tamehameha the Second, King of the Sandwich Islands, with his Queen Tamehamehu, having made a voyage to England in 1824, died in London in the month of July in that year. The Blonde, a new 46 gun frigate, under the command of Captain Lord Byron, cousin to Lord Byron the poet, on whose death he succeeded to the peerage, was put into commission with instructions to proceed to the Sandwich Islands and convey the bodies of the King and Queen for burial there. To this frigate (the Blonde) the deceased was, in August, 1824, appointed Chaplain. A special appointment was at the same time made, at the request Lord Byron, of Mr Andrew Bloxham, the present Rector of Great Harborough, as naturalist. The Blonde left Woolwich in September, 1824, and in the month of May, 1825, reached the Sandwich Islands. On the 11th of that month, the bodies of the King and Queen were disembarked, placed on funeral cars and solemnly conveyed to their resting place. The deceased Mr Bloxam, as Chaplain of the Blonde, read the funeral service, according to the rites of the Church of England, in English, after which an American missionary, stationed in the Island, addressed the assembled chiefs and natives in their own tongue. On the 18th of July, 1825, the Blonde left the Sandwich Islands. During its stay there the chaplain, Mr Bloxam, acquired several articles of great interest, some connected with Captain Cook; amongst these was a carved wooden image, the chief idol of the natives before their conversion to Christianity, and before which sacrifice was offered to Captain Cook, in whose voyages it is mentioned. He also obtained, as a gift from the Queen mother, Kahumanu, a costly feather war cloak. The Blonde, on its return to England, anchored at Spithead, on the 15th of March, 1826, after an absence of nearly 18 months. The notes of this voyage and of his sojourn at the Sandwich Islands, taken by Mr Bloxam, the Chaplain, were intended to have been published by him, but his appointment soon after his arrival in England to the Chaplaincy of the Dockyard at Bermuda, whither he had to proceed, precluded him from so doing. In 1826 Mr Murray, the well-known

publisher of Albermarle-street, published quarto volume copiously illustrated with engravings, entitled, "Voyage of H.M.S. <u>Blonde</u> to the Sandwich Islands, in the years 1824-1825." In the preface the editor says:—

"The following narrative has been compiled from the various journals, and notes made by some of the officers and other gentlemen that accompanied Lord Bvron on his interesting voyage to the Sandwich Islands. It is to be regretted that the Chaplain of His Majesty's ship Blonde, was prevented by the suddenness of his departure from England, in order to fulfil his duty in a distant colony, from arranging his own papers, and those of his companions. The Editor is conscious that some things may have been omitted, and some, possibly, mistaken, notwithstanding every endeavour to do justice the work, owing to want of that local knowledge which Mr Bloxam, as an eyewitness, must have possessed, and with which he would no doubt have extended and adorned hbis narrative, had fortunately remained to prepare it for publication."

Mr Bloxam continued as chaplain to the dockyard at Bermuda till the year 1829, when, on a vacancy occurring at Pembroke dockyard, South Wales, he was promoted to that chaplaincy, and returned to England. He was called up to London in January, 1830, on the sudden death of his uncle, Sir Thomas Lawrence, P.R.A. At the funeral the latter, on the 21st January, 1830, a quasi-public one in St. Paul's Cathedral, London, Mr Bloxam, as the eldest of the nephews, relatives in blood to the deceased, appeared as chief mourner. He and his brothers, in all six in number, immediately followed the coffin, the pall of which was supported by certain of the noblility and ministers of the crown. It was at this funeral, at which etiquette required a chief mourner, that the question arose amongst those who had the conduct of it, not amongst the relatives who followed, whether the brother-in-law of the deceased, the Rev. Dr. Bloxam, or his oldest son, nephew to the deceased, should officiate as chief mourner. Reference was made to the Herald's College to settle the question of precedency. A precedent was furnished of the funeral, marshalled Sir William Dugdale, Garter King at Arms, of Sir Willoughby Dixie, who died a.d. 1670, s.p., and at which the eldest nephew attended chief mourner, although his father was living. This decided the point, and the six nephews, the eldest by himself as chief mourner, followed immediately after the coffin, all the nephews taking, on this occasion only, as being of blood the deceased, precedence of their father. The celebrated landscape painter, J. M. W. Turner, R.A., made sketch of this funeral, exhibited the Royal Academy in 1830, and now hanging amongst the Turner drawings, in one of the rooms in the South Kensington Museum. In this, the coffin is represented as being conveyed into St. Paul's Cathedral through the west door, with the six brothers, nephews of the deceased following immediately after, and forming a group by themselves, the other mourners having apparently not as yet joined the procession. Forty-seven years have elapsed; but on Sunday last, the anniversary of that funeral, five out of the six brothers, all at the time of full age, who followed were alive.

LAMENTED ANTIQUARIAN AND OLD RUGBEIAN.

A remarkable Warwickshire antiquarian and gentleman was gathered to his forefathers on Tuesday in the person of the venerated and venerable MATTHEW HOLBECHE BLOXAM, of Rugby. In a county in which antiquarians have since the days of Dugdale held a foremost place for honest and thorough work, the name of Matthew Bloxam will rank among the highest. Few there are whose inclinations leads them to enquire into the mysteries of Ecclesiastical architecture who are not familiar with his Manual of Gothic Architecture. It is a work which has passed through eleven editions, and has contributed more than any similar work towards bringing a most interesting study within the grasp of the popular world. To the literature of his own county he has also made valuable additions. "The Churches of the Deanery of Warwickshire" was published under the superintendence of the Architectural Committee of the Warwickshire Natural History and Archaeological Society; and the whole of the architectural descriptions of the buildings as well of the sepulchral effigies and brasses were from his pen. He also published "British Antiquities of Warwickshire." For many years he was valued contributor to these columns, and interesting articles from his pen appeared in the journal of the Archaeological Institute, the Archaeologia Cambrensis - the journal of the Welsh Association; the Warwickshire Field Club Annual; and the "Meteor" - the journal of Rugby School. His position in the archaeological world is attested by appointment to honourable positions in numerous societies. He was not only a Fellow of the Society of Antiquaries, but was President of the Naturalist's and Archaeologist's Field Club of his own county; and was also Vice-President of the Cambrian Archaeological Association; Vice-President of the Worcester Diocesan Architectural and Archaeological Society; and honorary Vice-President of the Archaeological Institute of Great Britain and Ireland.

There scarcely a Rugbeian alive, of the historic days of ARNOLD or of his successor - afterwards Archbishop TAIT, or of HAYMAN or later of JEX BLAKE, who reads the announcement Mr BLOXAM'S death, but who will intuitively recall the figure of the unobtrusive and painstaking antiquary and attorney, who has lived, flourished, and adorned the town from his birth for 84 years. For the greater part of that time his doors have been open and his genial welcome and hospitality at the command of every boy who could obtain an introduction, and that was by no means difficult. Everybody knows his house. As you go up to the School from Sheepshed or High-street, you turn sharply the right, and a narrow flagged pathway leads to the familiar entrance of St. Matthew's. A pull

at the bell and a boy ushers you into the hall, hung around with pikes and guns and bows. The walls of his rooms are crowded with pictures, amongst which is a portrait of the master of the house, now familiar to many, through the engraving prefixed to the last edition of his work on Gothic architecture. The others include many studies and sketches by Sir Thomas Lawrence, the famous President of the Royal Academy, whose sister was Bloxam's mother; every nook and corner of the house is filled with some object of curiosity or article of antiquarian value, in which the owner took a deep interest and a just pride. Such briefly is the house of the Warwickshire worthy, whose place shall know him no more.

Of Mr Bloxam himself—his father was the Rev R. R. Bloxam, of whom the antiquarian at Old Rugbeian dinner once in his quietly humorous manner recounted :- "One hundred and four years ago my father entered Rugby School and ran away. He said he could not live Rugby; but as a school-boy, an exhibitioner, a master for thirty-eight years, managed to live there for sixty-three successive years." On May 12th, 1805, in a boarding house of Rugby, Mr M. H. Bloxam first saw the light, and in 1813 entered the foundation of LAWRENCE SHERIFF. From that day until his death he evinced the most loyal affection for his School, which the sad havoc of Time never impaired. His attachment to his old School is strikingly exemplified from his own modest words; once, when his health was drunk at an O.R. dinner, he said, "I have had five brothers at Rugby School, so that I have reason to think well of Rugby School. I nothing in myself, but as an O.R. I think myself some one. I wrote in the Rugby School Magazine forty-five years ago, and am still writing in the School Magazine. I am an old boy. I am still at Rugby School. I am a member of the Rugby School Natural History Society. I was brought up amongst Rugby boys. I have been all my life, and am still amongst Rugby boys"; and we may reverently add, he has died amongst Rugby boys, thereby adding to their deep sorrow the sense of general loss. His life was a peculiar and remarkable link - connecting the dead past and the living present; he had had a personal acquaintance of twenty old Rugbeians who were at the School one hundred years ago; and, as a member of the legal profession, he had transacted business with one who was at Rugby School in the reign of George II.; when he was himself at the School, a retired master died, who was alive in the days of ADDISON, and during the mastership of the famous HENRY HOLYOAK in the latter part of the seventeenth and early part of the last century. This HENRY HOLYOAK was one of the expelled from Magdalen College, Oxford, in 1681, by the order of James II. Gentle, courteous, studious, and persevering, the death of MATHEW HOLBECHE BLOXAM has deprived the county of one of the few remaining gentlemen and students belonging to class which is gradually dying out, and is not being replaced.

New Zealand public servant and plant collector chiefly interested in bryophytes and lichens. Some 230 bryophtye collections by Bloxam from Westland and Southland, made between 1866 and 1868, were deposited at Canterbury Museum (herbarium transferred to CHR).

Andrew R. Bloxam was the son of the Rev. Andrew Bloxam, who travelled round the Hawaiian islands as naturalist on the voyage of <u>HMS Blonde</u>. Andrew R. Bloxam later donated some items from this voyage to museums including the Bishop Museum in Honolulu, Hawaii.

Bloxam attended Worcester College, Oxford, before emigrating to New Zealand in 1863. At first he lived in Lyttelton, but after two years was appointed clerk of the warden's court at Kanieri, Westland. He spent 1872-1878 in England once more, then returning to New Zealand held an appointment at Greymouth (West Coast) before being appointed deputy registrar and deputy sheriff of Canterbury (becoming registrar and sheriff in two years time). He married his second wife in 1905, when he was over 70 years old. Sources:
